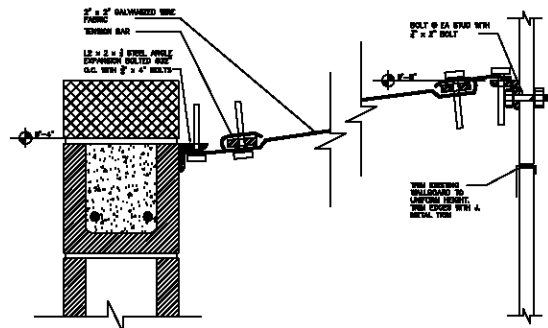
2 LIGHT COVE

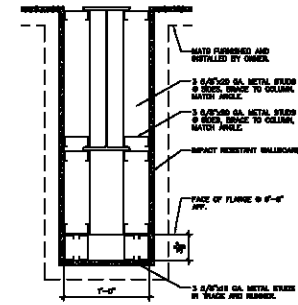
3 WALL CAP
